Day 1: What's New in School Law? (Fall 2019 Update) - Oct. 10, 2019; noon - 1:10 pm

Join LEGAL ONE staff attorneys in an information-packed webinar discussing the most recent school law developments affecting New Jersey's public schools. Included will be a discussion of recent legislative and regulatory enactments which impact school district operations as well as a case law update including decisions of the Commissioner of Education and the New Jersey and Federal courts. Topics will include, but not be limited to, tenure and seniority, labor relations, increment withholding, HIB, student rights, school safety, OPMA and OPRA.

Day 2: What's New in HIB Law? - Nov. 13, 2019; noon - 1:10 pm

This information-packed webinar will review the most recent legal developments in HIB affecting New Jersey's public schools. Included will be a discussion of recent legislative and regulatory enactments involving New Jersey's Anti-Bullying Bill of Rights Act and their impact on school district operations, staff and students. Participants will be provided with a case law update of recent HIB decisions of the Commissioner of Education and the New Jersey and Federal courts as well as emerging trends. Topics will include identifying acts of HIB, HIB procedures, board of education hearings, parent access to HIB information, the intersection of bullying and special education and the impact of the 2019 revised Uniform State Memorandum of Agreement Between Education and Law Enforcement Officials on HIB reporting.

Day 3: School Attorney Ethics 101 - Dec. 19, 2019; noon - 1:10 pm

Join David Rubin and Michael Kaelber in an introduction to the basic precepts of legal ethics that all school district counsel need to know; a great introductory course for attorneys new to the school law field and a terrific refresher for experienced school attorneys. Topics to be addressed include, who is the client, conflicts of interest, duties to adversaries, tribunals and third parties and much more.

Day 4: What's New in Tenure and Seniority Law? - Jan. 16, 2020; noon - 1:10 pm

Join LEGAL ONE staff attorneys in an information-packed webinar discussing the most recent developments in tenure and seniority law for school employees. Since the U.S. Supreme Court Janus decision and the enactment of the Workplace Democracy Enhancement Act, New Jersey has seen an uptick in employment litigation in general and tenure and seniority litigation in particular. This webinar will highlight the recent case law including issues of tenure acquisition, non-renewal, reductions in force, seniority rights, tenure entitlements and tenure arbitration dismissal decisions.

Day 5: What's New in School Employment Law? - Feb. 12, 2020; noon - 1:10 pm

Included will be a discussion of recent legislative and regulatory enactments affecting school employees and a school employment case law update. Case law topics to be considered include but are not limited to labor relations, tenure and seniority rights, HIB cases involving school employees, tenure arbitration cases and much more.
