### School Leaders Licensure Assessment (SLLA) Prep Sessions

Participants in this 15-hour series of hands-on prep sessions (5 sessions) will become familiar with the structure, content, and format of the SLLA — New Jersey’s required assessment for principal certification — through discussions, examination of sample test materials, question types, scoring criteria, and engaging in testing and scoring simulations. Participants examine appropriate responses to various test question types (e.g. multiple choice and constructed response) and discuss how they may be incorporated in exam responses.
