Employment Discrimination Law

Governance, Ethics, and Accountability

This online offering provides an overview of the law concerning school district governance, ethics and accountability for school officials, recordkeeping, and emerging issues of school law. The program contains the following important topics:

- The School Ethics Code and its application to board members; school administrators
- New Jersey's Open Public Records Act

NJ's Anti-Bullying Bill of Rights

New Jersey has adopted the most comprehensive bullying prevention law in the nation. In this course, participants will gain an understanding of the broad scope of the protections available to students and parents under New Jersey's law; the legal obligations related to preventing, identifying, investigating, and responding to potential incidents of HIB; and the broader obligations related to promoting a positive school climate and culture. The course includes a review of major case law since the law's adoption, revisions to state regulations, and a realworld cyberbullying scenario.

Signs Matter: Early Detection - New Jersey Online Suicide Prevention Training for K-12 Educators

Fulfill your state requirement and maybe save a life.

Signs Matter: Early Detection meets the New Jersey mandate for educators to have two hours of instruction on suicide prevention and bullying every five years.

Educators can play a critical role in the fight against suicide because they are in a unique position to notice

changes in the mental health of their students and identify signs of suicide risk.

Signs Matter: Early Detection is a two-hour online course that shows educators how and when to express concern and refer students to counseling staff or administration. The training is clear and simple, and it can save lives.

Training includes:

- A close look at the most common mental health problems and how they typically present in a school setting
- Real-world scenarios in an elementary, middle and high school setting to help you better identify students in need of help
- An online evidence-based assessment tool to ensure that all participants have gained an understanding of the material covered
- Resources for understanding a school's role in suicide prevention
- Review of legal requirements for schools to keep in mind

Special Education

This course addresses legal requirements under IDEA and Section 504. It includes a review of what constitutes a Free Appropriate Public Education, how do we determine the Least Restrictive Environment, how do we address issues of student discipline, and what due process protections are available for students and their parents.
