**Premier Active Membership** — \$845.00

Membership is open to any practicing New Jersey school administrator or supervisor. Premier Active members shall be entitled to all rights and privileges, including the right to vote and hold office, including but not limited to, election to the Council, to the Cabinet and to any officer position. A practicing school administrator or supervisor is defined to be anyone who has responsibility for the administration and/or supervision of school or district program and/or staff. Premier Active members are entitled to all NJPSA services and benefits. These include legal services, negotiations and field representation, association paid life insurance, professional development services, publications and much more.

**Aspiring Leader Membership** — \$80.00

Membership is open to any educator practicing in a New Jersey school district who is not currently serving in a school administrator or supervisory capacity. Aspiring administrator members are not eligible to hold office or vote but are permitted to serve on standing committees as non-voting members. Aspiring Members would not be permitted to serve as a committee chair.

**Retired Membership** — \$90.00

Membership is open to NJPSA members, with at least five (5) years of paid uninterrupted membership prior to retirement. Retired members are not eligible to vote or hold office.

**Lifetime Retired Membership** — \$385.00

Membership is open to NJPSA retired members with five (5) years of uninterrupted membership. The fee is paid once.

**Organizational/Support Services Membership** — \$450.00

Membership is open to any individual that provides, contributes or promotes services to the educational community. Organizational/Support Services members are not eligible to hold office or vote. Organizational members are entitled to NJPSA services and benefits. These include legal services, negotiations and field representation, association paid life insurance, professional development services and publications. Organizational members are not educators but support the educator's work. These may include building & grounds, food services, custodians, transportation, etc...

**Private School Membership** — \$430.00

Membership is open to any principal, headmaster, or supervisor working in a private school, whether secular or non secular, who is not a premier active member. Private school members may not hold office or vote. Private school members are entitled to contract negotiations but not legal representation. The Cabinet shall have the power to pass upon the qualifications of applicants for private school membership.

**Associate Membership** — \$180.00

Associate Members are those who are not practicing school administrators or supervisors, but who engage in educational pursuits. An associate member may include college or university professors. Associate members are not eligible to hold office or vote. Service includes publications, professional development opportunities and discount programs. This is an excellent inexpensive way to stay in the mainstream of the education community.

The Board of Directors shall have the power to pass upon the qualifications of applicants for NJPSA membership.
